

Video Visitation Rules and Regulations

Inmate non-contact video visitation may be held via the internet or at our Video Visitation Center located at 520 N. Falkenburg Road, Tampa FL, 33619.

All video visitations are by appointment only. All visitors must be listed on the scheduled visit.

Visitation Center hours of operation are Tuesday through Sunday 11:00 a.m. to 9:00 p.m. The first visit will be at 11 a.m. and the last visit will begin at 8:00 p.m.

Effective June 26, 2017: All visitors are required to check-in within the first 15 minutes of the scheduled visitation. Failure to do so will result in cancelation.

The Visitation Center will be closed on Mondays and all Sheriff's Office observed holidays, including Christmas.

Each inmate is permitted up to 3 visitors, at the Visitation Center, at one time; this includes children and infants. 1 must be an adult.

Inmates are restricted to 3 scheduled visits per calendar week, excluding professional visits. Visits scheduled by visitors who do not show, will count towards the inmates' allotted visits for the week.

All visitors under the age of 18 must be accompanied by an adult. Minors must be accompanied at all times.

Visitors under the age of 18 who are married to a facility inmate must provide a valid marriage certificate prior to the start of the visitation session.

Visitors must properly identify themselves upon arriving at the Visitation Center. Visitors must present a valid government issued photo ID indicating the date of their birth. Acceptable forms of identification include:

- Valid Driver's License
- Valid passport with photo attached
- Governmental agency issued photo identification
- Any license or identification issued by governmental agencies with a photograph encased or sealed in plastic

Identification that appears to be altered, modified, or is invalid will not be accepted.

All visits, excluding professional visits, are monitored and are subject to being recorded.

Visitors who leave the Visitation Center building before their session is over will not be permitted to reenter.

Visitors must be appropriately dressed, to include shirt and shoes. Clothing which is excessively revealing or which contains derogatory or offensive slogans or pictures are prohibited. Visitation staff will determine attire appropriateness.

A visitor who demonstrates inappropriate conduct while visiting, or on the premises of any Department of Detention Services Facility, will be permanently banned from any future visitation. Inappropriate conduct shall be defined as:

- Exposure of sexual organs (to include female breasts)
- Obvious physical impairment caused by drugs and/or alcohol
- Any other action that could compromise the security or orderly operation of the facility.

Car keys and wallets are the only personal items allowed into the Visitation Center. All other items should remain in the visitor's vehicle. For those utilizing public transportation, secure lockers are provided.

Visitors with infants and small children may bring a diaper bag and baby carrier subject to search into the Visitation Center. NO strollers will be allowed.

All children must be supervised so as to not interfere with other visitors. It is the visitor's responsibility to monitor their behavior. Adults of unruly children will be asked to leave with their child and the visitation session will be canceled. Repeat behavioral problems will result in suspension from visitation privileges.

CELL PHONES ARE NOT PERMITTED IN THE VIEWING AREA OF THE VISITATION CENTER. Visitors found with a cell phone will be asked to leave and have future visits suspended.

Taking photos of inmates during a visit is strictly forbidden and will result in a restriction of visitation privileges.

Visitors are expected to be courteous to other visitors. Loud talking, excessive emotionalism, or any other type of disruptive behavior will not be permitted in the Visitation Center. Failure to comply will result in termination of the session and may result in suspension of future visits.

Upon the conclusion of the visit, visitors are to leave the Visitation Center. Loitering in the building/parking lot or on the property will not be permitted.

Failure to follow any of the above rules may cause suspension or revocation of visitation privileges.
